What's new with the OCO?

Restrictive Housing Recommendations

The OCO released a Restrictive Housing Recommendations Report, which included the following DOC updates that we want to make sure you know about:

- DOC Headquarters is working on a new classification model that will bring significant changes and reduce solitary confinement.
- LWOP cases will be reviewed with other restrictive housing cases on a weekly basis.
- Health Services and Classifications will strategize an action plan that addresses medical holds in restrictive housing and creates more support for the incarcerated population.
- Restrictive Housing staff were reminded that maximum custody is the only disqualifying factor for placement in a transfer pod.
- WSP 440.000 was updated to send consumable items to the individual's living unit after it's been inventoried instead of using long-term storage.
- Mission Housing Manager will regularly review all individuals in restrictive housing.
